It is understood that the Membership Share shall be subject to the Bylaws of the Brattleboro Country Club, Inc., as amended, (and available on www.brattleborogolf.com or by request). It is further agreed that this subscription is irrevocable except as stated herein.

Designation of Type of Membership Share. The undersigned hereby agrees to purchase **One (1) Playing Membership Share in the Brattleboro Country Club, Inc. for \$1,500. 2009 playing dues FOR A SINGLE ADULT shall be waived.** A family membership for 2009 may be purchased for an additional \$1,000. **Purchase of a Playing Member Share carries with it the obligation to pay one adult annual dues (waived for 2009) for use of the golf course each year.**

THERE SHALL BE NO PAYMENT OF INCOME OR DIVIDENDS, NOR MAY THE SHARE AS PLEDGED OR SOLD TO THIRD PARTIES EXCEPT IN ACCORDANCE WITH THE BYLAWS OF THE BRATTLEBORO COUNTRY CLUB, INC.
